## Postage rates to climb in Jan.

WASHINGTON - It'll cost another penny to mail a letter next year.

The cash-strapped U.S. Postal Service said Thursday that it will raise postage rates on Jan. 27, including a 1-cent increase in the cost of first-class mail to 46 cents. It also will introduce a global forever stamp, allowing customers to mail letters anywhere in the world for \$1.10.

By law, the post office cannot raise prices more than the rate of inflation, or 2.6 percent. The agency, which expects to lose a record \$15 billion this year, has asked Congress for new authority to raise stamp prices 5 cents, but the House has yet to act. The Postal Service also will increase rates on priority mail shipping, by 4 percent. -AP

# We can solve our fiscal woes if we rise above partisanship

ARTISANSHIP in Washington is threatening to put the economy in recession at year's end, or else leave us with damaging levels of debt. Those are the options facing Washington if the two parties remain unwilling to come together and replace the socalled fiscal cliff with a thoughtful and gradual plan to put the debt on a more sustainable path.

If we do nothing, a combination of blunt and immediate acrossthe-board spending cuts, dramatic tax-rate increases and other changes will throw the economy back into recession while slashing important investments, crippling our military capabilities and raising taxes on ordinary Americans. Yet if we put off the day of reckoning, and continue what we're doing today, we will see our national debt rise to astronomical levels, leading to stagnant wages, higher interest rates on loans and, potentially, another economic crisis.

Both parties need to come together and agree on a third way forward — one that requires them to give up some of the programs and tax breaks they like for the country they love. Fortunately, our elected officials in Pennsylvania have been leading the way. Pennsylvanians know how to compromise on policies without compromising on principle to get things done.

There is no better example of this than U.S. Rep. Chaka Fattah. Congressman Fattah has his own plan to fix the debt — one that would ask all Americans to pay a small "transaction tax" in order to reduce the deficit. But he understands that the national debt is too serious a threat to hold out for his (or anyone's) perfect solution, and this week threw his support behind the bipartisan plan of the Simpson-Bowles Fiscal Commission. As he wrote to his colleagues, "The Simpson-Bowles proposal is the only solution before Congress that has bipartisan support in both chambers of Congress" and "there is no question the nation must begin to make some hard choices now."

The plan requires tough medicine for everyone, but the solution is clear: Democrats must accept changes to make our entitlement programs sustainable and Republicans must accept tax reforms resulting in higher revenue. Both sides are under intense pressure from groups trying to take options off the table. But the simple reality is that fixing the debt will require a bipartisan solution that looks at virtually all areas of the budget.

Congressman Fattah is not the only prominent Pennsylvanian putting country over party to pursue viable solutions.

Earlier this year, 38 brave members of Congress bucked the regular practice of voting along party lines on budget resolutions and instead supported a bipartisan budget. Among the 38 were five Pennsylvanians: Democratic Reps. Fattah and Allyson Schwartz and Republican Reps. Charlie Dent, Todd Platts and Pat Meehan.

As our debt continues to grow, more and more members of Congress from both parties are taking a second look at Simpson-Bowles. They are realizing that although it may not be their ideal plan, it represents the type of principled compromise necessary to deal with a problem of this magnitude while protecting the core values of both parties. And as we approach the fiscal cliff, members in both parties are correctly concluding that such a bipartisan solution is far preferable to the consequences of continued gridlock and inaction.

This issue is too important for continued partisan bickering. Our elected officials in Pennsvivania understand that, and I know the residents of this great state do as well. That's why I've decided to co-chair, along with former Republican Sen. Judd Gregg of New Hampshire, a new Campaign to Fix the Debt.

The Campaign to Fix the Debt is a joint effort of CEOs, former elected officials and leading budget experts, along with tens of thousands of concerned citizens. We have come together from all different backgrounds around a common goal: to urge Congress and the president to enact a comprehensive plan to put the country's debt on a stable and downward path. The stakes are incredibly high; the consequence of failing to act is almost unimaginable.

I urge my fellow Pennsylvanians to make their voices heard and join this campaign by visiting fixthedebt.org. There, you can sign a petition to let Washington know you are tired of partisanship getting in the way of action, and that it's time to come together on a comprehensive plan to get this done.

I also urge you to support the \$10 Million a Minute National Fiscal Responsibility Bus Tour, which comes to Philadelphia on Tuesday. You can find out more about it at 10millionaminute.com. You can also join us in spreading the word with your friends and neighbors and encouraging your elected officials to put the national interest ahead of special interest to fix the debt.

Pennsylvanians are leading the way in reaching real commonsense solutions, but much work remains to be done. We can't let this country go into another recession, or worse into fiscal crisis, because of rigid partisanship and unwillingness to compromise. That's not the Pennsylvanian way, and it isn't the American way.

### Online orders create more mail

Count on the U.S. Postal Service to deliver the record amount of purchases 130 million Americans are expected to make on Cyber Monday 2012, the biggest online spending day ever.

According to the National Retail Federation, or NRF, 51.8 percent of people will take advantage of Web-based sales.

"The holiday season is our Super Bowl, with 365 million packages expected to be delivered by the Postal Service this year," said Gary Reblin, vice president of domestic products.

The NRF predicts holiday sales to grow 12 percent this year to nearly \$100 billion. That means each person will do more than a third of their shopping online. The numbers continue to show support for the growing popularity of online shopping, which grew from \$72 billion in 2002 to more than \$250 billion in 2011.

## Only 186 USPS managers

#### take early retirement

Only 186 U.S. Postal Service supervisors and administrators signed up for the agency's early retirement offer.

Nearly 3,600 Executive and Administrative Schedule employees were eligible for the package, which allows employees to retire early if they are at least 50 years old with a minimum of 20 years' service, or any age with at least 25 years' service. Unlike recent early retirement offers to postmasters, mail handlers and clerks, however, this one was not coupled with a buyout.

"If there was an incentive, you could have gotten a lot more," Louis Atkins, president of the National Association of Postal Supervisors, said in an interview.

Those who have accepted the offer must leave by year's end.

#### USPS projects record holiday package deliveries

The U.S. Postal Service expects a record 20 percent increase in its package business this holiday season, Postmaster General Pat Donahoe announced last week.

The mail carrier will deliver a projected 365 million packages, up from about 300 million, between Thanksgiving and New Year's Eve, Donahoe said at a holiday kickoff event.

and enterprise software has met a key government security standard.

This is the first time BlackBerry products have been certified pre-launch for meeting the government's data encryption requirement. The certification is issued by the National Institute of Standards and Technology.

The new BlackBerry products are expected to launch early next year.

NIST authenticates hardware, software and firmware used to encrypt data on mobile devices used in government. The Defense Department is holding off on widespread use of products such as Apple smartphones and tablets as they undergo NIST's certification process.

## **USPS tries same-day delivery for holidays**

WASHINGTON — Emboldened by rapid growth in e-commerce shipping, the cashstrapped Postal Service is moving aggressively this holiday season to start a premium service for the Internet shopper seeking the instant gratification of a store purchase: same-day package delivery.

Teaming up with major retailers, the post office will begin the expedited service in San Francisco on Dec. 12 at a price similar to its competitors'. If things run smoothly, the program will quickly expand next year to other big cities such as Boston, Chicago and New York. It follows similar efforts by eBay, Amazon.com and, most recently, Wal-Mart Stores Inc., which charges a \$10 flat rate for same-day delivery.

The delivery program, called Metro Post, seeks to build on the Postal Service's double-digit growth in package volume to help offset steady declines in firstclass and standard mail. Operating as a limited experiment for the next year, it is projected to generate between \$10 million and \$50 million in new revenue from deliveries in San Francisco alone, according to postal regulatory filings, or up to \$500 million, if expanded to 10 cities. The filings do not reveal the mail agency's anticipated expenses to implement same-day service, which can work profitably only if retailers have enough merchandise in stores and warehouses to be quickly delivered to nearby residences in a dense urban area. The projected \$500 million in potential revenue, even if fully realized, would represent just a fraction of the record \$15.9 billion annual loss that the Postal Service reported last week.

But while start-ups in the late 1990s, such as Kozmo.com, notably failed after promising instant delivery, the Postal Service's vast network serving every U.S. home could put it in a good position to be viable over the long term. The retail market has been rapidly shifting to Internet shopping, especially among younger adults, and more people are moving from suburb to city, where driving to a store can be less convenient.

Postal officials cast the new offering as "exciting" and potentially "revolutionary." Analysts are apt to agree at least in part, if kinks can be worked out.

"There is definitely consumer demand for same-day delivery, at the right price," said Matt Nemer, a senior analyst at Wells Fargo Securities, in San Francisco. "The culture in retail traditionally has been to get a customer into the store, with the immediacy of enjoying a purchase being the main draw. So, same-day delivery could be huge for online retailers. The question is whether the economics can work."

He and others said that consumers are a fickle lot when it comes to shipping, seeking fast delivery but also being sensitive to its pricing. Many will order online and pick up merchandise at a store if it avoids shipping charges, or will agree to pay a yearly fee of \$79 for a service such as Amazon Prime to get free and unlimited two-day delivery. Others even purchase a higher-priced item if it comes with free shipping.

Under the plan, the Postal Service is working out agreements with as many as 10 national retail chains for same-day delivery. The mail agency says that nondisclosure agreements don't allow it to reveal the companies. But given the somewhat limited pool of large-scale retailers — they must have a physical presence in 10 or more big U.S. cities to be a postal partner — the list is expected to include department stores, sellers of general merchandise, clothiers, even perhaps a major e-commerce company or two.

Consumers will have until 2 or 3 p.m. to place an online order with a participating retailer, clicking the box that says "same-day delivery" and making the payment. Postal workers then pick up the merchandise from nearby retail stores or warehouses for delivery to homes between 4 and 8 p.m. that day.
