USPS sets in motion plan to cut post office hours

The U.S. Postal Service last week began notifying customers in nearly 500 communities of its plans to cut hours at their post offices.

The formal notifications set in motion plans for historic cutbacks throughout the USPS network of almost 32,000 post offices. Over the next two years, the financially beleaguered mail carrier intends to reduce customer service window hours to as little as two hours a day at some 13,000 post offices that do relatively little business.

After follow-up public meetings that start in October for the first batch of communities notified, the cuts could take effect soon after a spokeswoman said.

The Postal Service, which last week reported losing almost \$1.9 billion in July, unveiled the Post Office Structure Plan (POSt-Plan) in May after a bid to close up to 3,700 post offices ran into heated resistance from

affected communities and members of Congress. Opposition to the cuts in service hours has been far more muted.

In an Aug. 23 advisory opinion, the Postal Regulatory Commission said the plan "should help balance service and cost savings" if implemented properly. While the five-member oversight panel offered a number of recommendations — urging the Postal Service, for example, to conduct an internal review to ensure that the endeavor is meeting its goals — it viewed the plan as preferable to post office closures.

The opinion was welcomed by USPS officials, who expect the cuts to eventually save more than a half-billion dollars in annual labor costs. About 12,500 of 21,000 full-time postmaster positions will disappear, replaced in many cases by cheaper part-time jobs. Already, some 3,800 postmasters have left in response to a \$20,000 buyout and early retirement package offered as part of the plan. Several hundred more could follow by the end of this month.

Critics, however, question whether the Postal Service can quickly make up the loss of so many employees without hurting service. Standard hiring practices "will be wholly inadequate to replace the exodus of postmasters with qualified personnel," Emmett Costich, a PRC employee charged with representing consumers, wrote in a filing with the commission.

And even after cutting window hours at a particular post office, USPS officials could still later seek to close it, Costich said.

USPS spokeswoman Sue Brennan disputed both those points. The Postal Service has no plans to close those post offices, "unless the community overwhelmingly chooses that option" and has "absolutely no concerns" about filling the postmaster vacancies, Brennan said in an email.

James Campbell, a postal policy consultant, saw more aggressive reductions as inevitable. Although the Postal Service may have found a way "to make marginal improvements in a more politically acceptable way," Campbell said in a phone interview, "they're just nibbling at the edges."

The Postal Service last week also offered early retirement to more than 3,300 of about 55,000 managers on its Executive and Administrative Schedule. It is in the early stages of slashing its network of approximately 460 mail processing plants by about half. In this instance, as well, postal leaders retrenched after lawmakers objected. Not only did they delay the bulk of the closures and consolidations until after the November elections, they also stretched out the full implementation period from next year into at least 2014.

"As far as the politics of it, I think they are doing what they need to do," said Gene Del Polito, president of the Association for Postal Commerce, which represents commercial mail users.

But existing law limits the Postal Service's ability to stem its losses. Efforts to devise a legislative fix are stuck on Capitol Hill, prompting customers to consider alternatives to the mail, Del Polito said.

USPS again defaults on health care payment


For the second time in two months, the U.S. Postal Service has defaulted on a legally required payment into a fund for future retiree health care benefits.

 The \$5.6 billion payment was due Sept. 30. USPS executives, who had long acknowledged that they lacked the money to cover it, again stressed last week that normal operations would not be affected.

"We will continue to deliver the mail and pay our suppliers," spokesman Dave Partenheimer said in a statement, adding that benefits for current employees and retirees will also remain untouched.

The payment for fiscal 2012 is required under the 2006 Postal Accountability and Enhancement Act as part of a plan to ensure adequate funding for future retirees' health care; in August, the Postal Service failed to make the \$5.5 billion installment for fiscal 2011. That payment was originally due in September 2011, but Congress postponed it.

Lawmakers have declined to grant further delays, but remain deadlocked on how to address the Postal Service's fiscal problems.

STEWARDS CORNER

EXTON - In Exton we arealmost free of the last vestiges of the caser/deliverer pilot program. Two cases were recently sent to the DRT. One involved the FSS adjustments that a Memorandum of Understanding between the NALC and the Postal Service states that we are entitled to 60 days after the FSS adjustments take effect. Oddly, local management and the Union agreed that we were entitled to these adjustments. When Postmaster Joseph Williams called the District to ask for help completing the 3999 walks, which are necessary to compile accurate data on the newly adjsted routes, hw was told by Curt Weinberger, aka high school haircut guy, aka the "weasel", that we were not entitled to those adjustments, since the routes were all walked during the pilot program. Since the adjustments for the pilot program and the ones for FSS were completely different, his argument made no sense. The DRT agreed, and the routes that the Union and Management feel are out of adjustment will be walked.

The other case that is at the DRT involves the out-of-schedule premium that we were entitled to by the National Agreement and that was awarded by the DRT in a previous decision. The Union also contends that all Exton Carriers are entitled to a punitive award since the Postal Service took so long to pay us the money that we were due per the February DRT decision. All the Exton Letter Carriers received their past due out-of-schedule premium last month, but we are asking for an additional \$10.00 a day, per Carrier, for each day after February 29, 2012, that the premium owed was not paid. These kind of cases can go either way, so don't spend that money yet.

Hatch Act

Before 1993, active letter carriers were barred from taking any significant volunteer role for any campaigns. The primary purpose was to protect Federal employees from being strong-armed into helping their bosses run for reelection. But as times changed, many believed that Federal employees were being wrongfully left out of the political process. So in 1993 Congress amended the Hatch Act to allow Federal employees to take an active part in political campaigns for Federal offices. While there are still some restrictions on what active carriers can do, there is indeed greater latitude given to your participation. Thanks to changes in the Hatch Act, active Letter Carriers have been able to participate in campaigns for President, United States Senate, and House of Representatives.

Remember: Retirees, spouses, and family members are not bound by the Hatch ACT!

Active Carriers MAY:

- Be a candidate for public office in nonpartisan elections
- Register and vote as you choose
- Assist in Voter Registration Drives
- Express opinions about candidates and issues
- Attend fundraisers and contribute money to political organizations and campaigns
- Volunteer on a campaign
- Recruit volunteers for a political campaign
- Participate in activities such as phone banking and precinct walking
- Display bumper stickers, lawn signs, and other campaign paraphernalia
- Raise money for COLCPE from other Letter Carriers
- Run for nonpartisan offices (that is, parties are not listed on the ballot)
- Volunteer, run for, and hold an office in a local or state political party

Active Carriers MAY NOT:

- Raise money for a partisan political campaign
- Run for political office (even if you report "No Party Affiliation")
- Allow your name to be used in any fundraising appeal on behalf of a partisan political campaign
- Participate in a phone bank that is engaged in fundraising for a partisan campaign
- Raise money for COLCPE from non-Letter Carriers
- Bottom Line: Be off the clock, out of the uniform (and government vehicles), and away from the work place


Dan Smith has resigned as our steward in Malvern. Branch 4317 would like to thank Dan for his years of service to the Carriers in Malvern.


We passed a resolution at the October meeting regardding T.E.s. In the future Transitional Employees will receive there refund checks at Unions meetings after there break in service.

The Republican Party last week approved a party platform that calls for cutting the federal workforce by at least 10 percent, overhauling federal pay and benefits, and privatizing airport screening and possibly some U.S. Postal Service operations.


Although the document, approved Aug. 29 at the Republicans' Tampa, Fla., convention, acknowledges the dedication of federal employees, it said the civil service has grown by at least 140,000 employees under the Obama administration, while the number making \$150,000 or more has doubled.

"At a time when the national debt has increased to over \$15.9 trillion under the current administration, this is grossly irresponsible," the platform

John Palguta, vice president for policy at the Partnership for Public Service, said he is unaware of any other presidential platform that has addressed federal employee issues so specifically.

But Palguta suspects that even if Republican presidential candidate Mitt Romney wins, it's unlikely the GOP will fully enact the federal employee aspects of its platform.

Romney would find it difficult to cut Defense, Veterans Affairs and

"That [plank in the platform] was written by someone who believes federal pay is above market value," Palguta said. "But we think we have examples of jobs that are below market value, so it could work for the betterment of some employees."

Convention speakers did not address federal issues directly. But several, including vice presidential nominee Rep. Paul Ryan, R-Wis., spoke about the need to rein in government spending and the deficit.

"The choice is whether to put hard limits on economic growth, or hard limits on the size of government, and we choose to limit government," Ryan said in his acceptance speech Aug. 29. □

Democrats reinforce support for unions in platform

The Democratic Party reaffirms its support for collective-bargaining rights for public-sector workers in its 2012 platform, which it released last week.

"Democrats believe that the right to organize and collectively bargain is a fundamental value," the platform said. "Unions helped build the greatest middle class the world has ever known. We will fight for collective bargaining rights for police officers, nurses, firefighters, emergency medical technicians, teachers and other public sector workers — jobs that are a proven path to the middle class for millions of Americans."

The platform also calls for Congress to grant President Obama the power to reorganize and consolidate government agencies, an authority past presidents have had. And it touts Obama's efforts to get agencies to review and

streamline outdated regulations.

"For too long, overlapping responsibilities among agencies have made it harder, rather than easier, for our small businesses to interact with their government," the platform said.

Obama reinforced that message in his acceptance speech to the Democratic National Convention on Sept. 6.

"Those of us who believe government can be a force for good should work harder than anyone to reform it so that it's leaner and more efficient and more responsive to the American people," Obama said. Obama also said he wants to strike a deal with Republicans to reduce the deficit "based on the principles of my bipartisan debt commission," headed by former Sen. Alan Simpson and former White House chief of staff Erskine Bowles. But Obama did not specifically endorse the Simpson-Bowles deficit plan.

"No party has a monopoly on wisdom," Obama said. "No democracy works without compromise. ... We don't think the government can solve all our problems. But we don't think that the government is the source of all our problems, any more than are welfare recipients, or corporations, or unions, or immigrants, or gays or any other group we're told to blame for our troubles."

The platform lauds Democrats' efforts to enact the STOCK Act, which requires top government officials to report stock purchases and other securities transactions worth more than \$1,000. And it says Democrats are committed to open-government programs such as Data.gov.

The Republican Party's platform calls for cutting the federal workforce by at least 10 percent, overhauling federal pay and benefits, and privatizing airport screening and possibly some U.S. Postal Service operations. The Democratic platform does not address those issues.
